JJH & Wheeler Corporate Trip - Customer Guidelines

1. Trips will be awarded to the customer account, not to individuals. It is the responsibility of the customer to select the individuals who will participate and to issue 1099's as applicable. JJ Haines and Company will issue 1099's to all accounts that are LLC's, partnerships or sole proprietorships. Corporations will not be issued a 1099.
2. Dealer's receivables must be current to receive any award.
3. No refunds will be made for any unused points or over-bills.
4. If Dealer cancels or moves points to a future trip, only trip promotion fund points will be moved. Any promotional or double dip points funded by suppliers only count toward Punta Cana 2011 trip fund.
5. A second trip may be purchased only after a first trip has been earned. A fourth trip may be purchased after the 3rd trip is earned. In other words, every even trip may be purchased after the odd number trip is earned.
6. See attached Trip Promotion Fund for fund guidelines.
7. A dealer will not be confirmed on any trip nor will points be accumulated without a completed sign-up form and a non-refundable deposit fee of \$500 per trip. Deposit counts towards the total trip cost.
8. This trip is based on a first come, first served basis. Limited space is available.
9. Dealer trip cost is 295,000 points per trip based on double occupancy. One trip equals one person. This includes the non-refundable \$500 deposit.
10. Single occupancy cost 395,000 points per trip. One trip equals one person.
11. Kids: 5 to 17 costs 146,000 points with an adult couple. Kids 4 and under 119,000 points with an adult couple.
12. Air travel is from Baltimore Washington International, Richmond, Charlotte, Philadelphia, Raleigh-Durham, Orlando, Tampa and Miami. Any deviation from the airports listed will result in an up charge.

Haines Cancellation Notice

- **July 12, 2010:** Trip Coordinator will contact your account in writing and confirm your status for attending the 2010 trip.
- **Up until July 30, 2010:** Cancellations are subject to the non-refundable \$500 per trip deposit. If approved, funds in account will transferred in dealer's account for use on a future designated trip.
- **Between August 1 – September 30, 2010:** Any cancellation is subject to a \$500 per trip penalty.
- **Between October 1 – November 23, 2010:** Any cancellation is subject to a \$900 per person penalty.
- **Beginning November 24, 2010:** Any cancellation is subject to 100% per person penalty.
- **NOTE: After November 7, 2010, no name changes allowed:** Air will be booked starting November 8, 2010.
